Fingerprint/SIDA/AOA/STA Fees

FINGERPRINT ONLY FEES

- \$ 40.00 UND Alien Contract Students (with UND Representative)
- \$ 75.00 - Alien Students Training at GFK including UND Non-Contract Students
- \$ 70.00 - UND Trusted Agent Only (No Badge Issued)

SIDA BADGE

- \$ 80.00 - (Includes Fingerprints, STA, Badge, recordkeeping)
- \$ 45.00 - (TSA employees - SIDA Badge Only - with or without STA)

AOA BADGE

- \$ 40.00 - (With or without STA)

ACCESS ONLY BADGE

- \$ 15.00 - UND with STA already on file.

LOST/STOLEN BADGE (SIDA/AOA/ACCESS)

- \$ 75.00 - First Occurrence
- \$ 100.00 - Second Occurrence
- \$ 500.00 - Third Occurrence

NOTE: If badge found or returned within 60 days of lost notification and payment, a partial refund is:

NOTE: No refund after 60 days.

NOTE: No charge for stolen badge with copy of police report.

NON-RETURNED BADGE (SIDA/AOA/ACCESS)

- \$ 100.00 - assessed to the signatory responsible for badge.

BADGE RE-ISSUES ONLY (Upon Badge Expiration Every Other Year)

- \$ 15.00 - AOA Badge (including STA update, new badge, recordkeeping)

STA PROCESSING ONLY

- \$ 20.00 administrative minimum fee (including STA, recordkeeping/supplies, no badge issued)
